# Training for instrument rating

#### Scholarship description and eligibility criteria

Up to five scholarships for up to \$12,000 each in training towards an instrument rating will be awarded to qualified applicants as determined by the review board. These scholarships will primarily be funded by the Ellsworth Hovey Getchell Foundation, including one in the name of the Munro family. One scholarship may be funded by Mach 5 Aviation.

Successful applicants will be expected to train intensively during the summer of 2025, studying for the FAA written examination as well as flying three to four days per week.

Applicants must be no older than 25 years as of September 30, 2025. As of January 31, 2025, they must hold a private pilot certificate. Unless enrolled in a Part 141 program, they must have 20 hours of pilot-in-command cross-country time prior to commencing flight training under this scholarship. Applicants must reside in the California counties of Amador, El Dorado, Nevada, Placer, Sacramento, Sutter, or Yuba. An FAA medical certificate appropriate to the training to be undertaken will be required prior to the start of training under this scholarship.

Instruction and training under this scholarship must be accomplished at one or more of the following flight schools located at Auburn Municipal Airport (KAUN):

Mach 5 Aviation Sierra Air Helicopters Sky Trails Aviation Sunshine Flyers

The deadline for passing the written examination is June 30, 2025. The applicant must have been signed off by his/her flight instructor as eligible for the FAA flight check for the instrument rating by November 30, 2025. Waivers from these requirements may be considered. Funding will be in two installments. The first installment will be \$5500. Funding for the second installment will be dependent upon the student having passed the written examination.

Ground school costs up to \$300 and FAA written examination costs up to \$200 will be reimbursed from scholarship funds.

Persons who are prior recipients of \$10,000 or greater scholarships from any of these sponsors or the Aerospace Museum of California are ineligible for the 2025 scholarships.
